The calculation of a regular scholarship of a full-time Ph.D. student at FM VŠE

A full-time student receives a regular scholarship of CZK 8,000 per month upon entering the programme. Of this amount, CZK 4,000 is the unconditional part, and CZK 4,000 is the conditional part. The conditional part is granted based on the attendance at the doctoral seminars (student attends at least two-thirds of the seminars held in English). For students in their first semester, the conditional part is granted automatically. The attendance is evaluated at the end of each semester. The scholarship is recalculated after the end of the current semester.

For each examination passed, a full-time student receives a monthly scholarship of CZK 500. A maximum of six exams is recognized. Three classes must be compulsory and one compulsory elective (the other two may be both elective or one compulsory and one elective; by agreement, courses in academic writing organized by the Academy of Sciences of the Czech Republic, or other courses organized by other faculties). The scholarship is recalculated after the end of the current semester.

For passing the State Doctoral Examination, a full-time student receives a regular monthly stipend of CZK 5,000. The scholarship is recalculated after the end of the current semester.

A full-time student receives a regular monthly scholarship for participation in teaching (up to the amount required by the Doctoral Standard). The regular stipend for each direct lesson taught is increased by CZK 50 (i.e., for two lessons per week, this is CZK 1,300 per semester taught). Teaching more than the requirements of this regulation (total of 3 ECTS credits, e.g., teaching more than two hours per week for three semesters) does not count in the regular monthly scholarship (but is recognized as a special stipend awarded four times a year based on collected evidence). The scholarship is recalculated after the end of the current semester.

For a successfully defended qualification thesis, where the student participated as a thesis supervisor, the monthly scholarship is increased by 100 CZK. The scholarship is recalculated after the end of the current semester.

A full-time student receives a regular scholarship for publishing activities (publications must be affiliated to the FM VŠE and reported). For each publication point, according to the Publication Standard, the regular monthly stipend is increased by CZK 600. The maximum recognized number of publication points that contribute to the regular scholarship of a full-time student is 10. (i.e. CZK 6,000 per month).

Students (both forms, full-time and blended) also receive a special stipend for any publication affiliated to FM VŠE (and properly reported). The stipend reflects the quality of the publication according to the [Allocation of Institutional Support Funds Aimed at the Long-term Conceptual Development of the Faculty of Management of the Prague University of Economics and Business](#).

Illustrative example:

A second-year student has passed four compulsory classes, has taken a course in academic writing, has participated in teaching for two semesters for two hours per week, has supervised two (successfully defended) theses, has attended 2/3 doctoral seminars in the last semester (held in English), and has just published a CPCI conference proceedings paper:

4,000 (unconditional part) + 4,000 (conditional part for seminar attendance) + 2,500 (five courses taken) + 2,600 (2 × 26 hours taught in total over two semesters) + 200 (two successfully defended theses as supervisor) + 1,200 (2 publication points for CPCI paper × 600), for a total regular monthly scholarship of 14,500 CZK
